Mannix College Financial Assistance Scholarships 2022

Mannix College will award a number of scholarships for the 2022 year. Each will be worth \$5,000 and will take the form of a reduction in residential fees.

These scholarships are offered to help enable students from low-income backgrounds live at Mannix College while studying at Monash University.

Students wishing to be considered for as scholarship are asked to:

- Complete the application form, and email to mannix.scholarships@monash.edu, or;
- Complete and print the application form, then post, marked "private and confidential" for the attention of the 'Business Manager, Mannix College, 22a Wellington Road, Clayton Victoria 3168'

Application Criteria

The following will be taken into consideration when assessing your application:

- Demonstrated low income
- Location – preference will be given to applicants from rural or regional areas
- You must be an Australian citizen
- You must be intending to enrol at Monash University on a full-time basis in 2022 (scholarships will be awarded provisionally upon your acceptance)

Please note, there is a separate application process for entering Mannix College. To be considered for a scholarship you must also submit a residency application, no later than Friday 17 December 2021.

We understand that you may be reluctant to apply to live at Mannix College without knowing whether you'll have a scholarship or not. However, you will not have to pay any College fees if your scholarship application is unsuccessful.
